Gaslighting America - Comments by Hugh Tebault September 2021

The core of America is individual liberty and responsibility is about self and family. In America, we have chosen to work together as a Republic, under our state and US Constitutions. In those constitutions, we the people give SOME of our power, which we receive from our Creator, to a limited government operation. Each state is unique, but the US Constitution establishing the federal government of three branches, is set and limited to those specific duties named in the Constitution.

From this framework, we have established a long-standing experience of laws that apply equally to all, and a representative government who acts as an agent of the citizens

Key to our success, we share our experiences with a common language so that we can accurately communicate, and as needed discuss and change events to improve our own lives.

When we find words being deliberately used with different meanings, and laws either twisted by those altered meanings, or ignored there is a problem. With the advent of the Wuhan Virus (COVID-19), a few of the common words being mis-used and altered have included;

Word: Vaccine a known treatment that generally uses a small amount of a substance that the body must protect itself against, injected into a person. That injection then allows the body to naturally react and create an antibody protecting itself. We have a long medical history of its general use and known side effects. Not every vaccine is 100% effective and is often only proscribed to individuals based on their medical risk at a doctors finding.

Word Change: – Vaccine - a lab created message (mRNA) telling all cells to do something – bypassing the body own system of creating antibodies, and protecting itself. This is SAID to be a good thing by the drug companies and politicians, but has never passed any long term safety testing.

CDC actually changed wording on their website Sept 9, 2021 –

From 2015 to Aug. 31, 2021, a vaccine [was defined](#) as “a product that stimulates a person’s immune system to produce immunity to a specific disease, protecting the person from that disease” and vaccination was “the act of introducing a vaccine into the body to produce immunity to a specific disease.”

[Earlier versions](#) of a vaccine definition also included “immunity” in its definition.

The [new definition](#) for the vaccine now reads, “A preparation that is used to stimulate the body’s immune response against diseases,” while vaccination is “the act of introducing a vaccine into the body to produce protection from a specific disease.”

Rep. Thomas Massie (R-Ky.) took to Twitter about the CDC’s definition change and compared it to George Orwell’s “1984,” writing, “They’ve been busy at the Ministry of Truth.”

Word: Emergency Use Authorization (EUA) A clause in the law, allowing the FDA to temporarily approve the use of an untested item when there is NO OTHER TREATMENT available. Considered as a last-ditch effort and to be used by high risk users who have no other options.

Word Change: Emergency Use Authorization (EUA) A method to bypass the existing law, and combined with the political denial of existing, known medical treatments, forces a new, untested treatment method into the marketplace. Significant to this has been the denial of [licensed Doctors opinions on successful treatment](#) protocols that included nutrition, items like zinc and other natural components as well as the protective treatment using low dose Hydroxychloroquine, or Invermectin. Given there are treatment options currently available, it is not a legal use of the EUA.

Word: Vaccine Approval – A legally identified process, carried out by the FDA with defined rules and timetables. This is administered by the FDA, and based on a law from Congress. The practice is a published administrative rule, and must be followed.

Word Change: Vaccine Approval – A politically driven “approval” of a mRNA treatment waiving the safety requirements, and ignoring the existing 14,000 reported deaths from the mRNA treatment. The FDA failed to hold public hearings, a step legally required in the process to approve and simply forced an expedited “Approval” to the experimental mRNA treatment.

Word: Case (as in a medical case) A medical case is something that a medical Doctor has seen and issued a diagnosis. The Doctor MAY have done one or more tests to reach their decision. The Doctor would then recommend a level of treatment for the patient based on the facts the Doctor observes.

Word Change: Case (covid-19) A test result of a PCR lab test – no Doctor’s opinion. Without knowing the PCR CT value used, it is scientifically inaccurate to consider this a medical case. In 2020 the CDC recommended a CT value of 40, which virologists state will return over 90% false positive results. Early in 2021, the CDC changed their recommendation to 30-35, which is better but also returns false positives. (A false positive sample could not be grown in the lab, so is not infectious or active). Note that even the World Health Organization warns NOT TO ONLY use a PCR test result as a measurement.

In addition to manipulating the words, several states have also politicized bureaucratic agencies, usurping their legitimate operation, to harness it to control.

State Board of Medicine

a state agency to license medical doctors in the state. Their established requirements are public, but the agency normally has little or nothing involvement in the individual Doctors medical decisions or choice of medical treatments. There are exceptions where due to extreme issues, a State Board of Medicine MAY investigate a doctor for cause.

However, some states had a Governor order the medical authority to LIMIT, or DISALLOW specific treatments the Governor choose. This is an abortive control method overriding the

proper medical, scientifically based decisions to nothing more than a politically controlled agency not following laws.

State Board of Pharmacy

a state agency to license and manage drug sales within the state. Their licensees have known requirements and expectations that they will safely manage the drugs, only issue properly proscribed medication and record all those transactions. The medicines carried may be limited to only drugs listed by the CDC, or other known requirement. The Board of Pharmacy may also request the licensee to report any abnormal activity, especially in the class 1 drugs. This gives the state a heads up of possible illegal activity.

However, some state Governors had ORDERED the Board of Pharmacy to limit, or block the prescription of existing medication. This politically changed Doctors medical decisions not based on any science, just political power. Significant to this has been the denial of [licensed Doctors opinions on successful treatment](#) protocols that included nutrition, items like zinc and other natural components as well as the protective treatment using low dose Hydroxychloroquine, or Ivermectin.

State OSHA

a state agency to establish certain business safety standards helping limiting harm to employees in the state. In practice, OSHA standards are published, and often based on nationwide safety practices. OSHA does not cover personal choice, or enforce any medical practices.

In some states the Governor ordered the use of MASKS – and then used OSHA as an enforcement arm of that mandate. It was again, not based on laws, or on publicly chosen practices – but on the political choice of a Governor without any scientific basis.

By the manipulation of these several phrases, entire laws, government departments, policies and practices have been altered or eliminated without benefit of a change in law at all. In the United States, our Constitutional rights are ABSOLUTE. While in a very limited way, during an actual localized public emergency, like during a hurricane, some of those rights may be delayed, but only for the least time and in the most limited way possible.

However, the choices to harness this “emergency” to turn upside down our Constitutional Rights, and ignore laws, replacing them with mandates by bureaucrats is the same pattern that President Clinton employed when he infamously said “It depends on what the meaning of the word 'is' “is.

It is simply immoral, and Unconstitutional.
